Due to COVID-19 and the fact that the City had to cancel their regularly-scheduled meeting on September 15, 2020, due to Hurricane Sally, Architect Christian Landry has requested that the following change be post-approved:

Authorize the public advertisement for bids for the construction of the City Square Park Pavilion, with bids to be accepted until 2:00 p.m. on October 20, 2020, at the Poplarville City Hall, located at 200 Highway 26 East, Poplarville, Mississippi, at which time and place they will be publicly opened and read aloud in the Board Room at City Hall, and to authorize Landry, Lewis, and Germany Architects, P.A. to publish the Advertisement for Bids in The Poplarville Democrat newspaper on September 17, 2020 and September 24, 2020.

- Burial of Urns in City Cemeteries A citizen has inquired as to whether three urns can be buried within the same cemetery plot, with one tombstone/monument erected on said plot. Our current Cemetery Ordinance allows for one monument to be erected per plot. However, in regard to urns, it just mentions how many urns may be placed in a columbarium. (This matter was taken under advisement on August 4, 2020.) Below are excerpts from the City's Cemetery Ordinance:
 - **Section 9**: Only human remains shall be buried in the City Cemeteries. The grave for anybody or cremated remains shall be within a burial vault or grave box (concrete, steel, fiberglass or plastic), casket, or urn/cremation container. All grave boxes, caskets, and buried urns shall be buried at a depth of at least four feet six inches (4'6"), and shall have at least twenty-four inches (24") of tamped earth on top of the grave box, casket, or urn. Each plot shall have only one upright monument or headstone.
 - Section 10: A columbarium may be erected, at the plot owner's expense, above ground on a funeral plot. Only one columbarium may be erected on any plot, and the columbarium shall not encroach upon any surrounding plot. No columbarium erected in any City Cemetery shall rise more than five (5) feet above the ground surface. A columbarium may contain multiple niches. Up to two (2) containers of human cremains may be placed in a single columbarium niche.
