 - 14.1 Superintendent Hale will provide an overview of recent work activity.
 - 14.2 Consider performing sewer trench repairs at the following locations:

Engage The Walker Associates, PLLC, represented by Jason Lamb, Engineer, will discuss the following potential sewer trench repair projects:

- North Main Street (7 feet wide, by 700 feet in length)
- Roy Street (10 feet wide by 115 feet in length & 8 feet wide by 70 feet in length)

Magehee Street (8 feet wide, 50 feet in length)

The scope of work will consist of removing the existing pavement in failed areas, over excavation of unsuitable soils, backfill with select fill material at desired compaction density, and place crushed limestone along the surface to maintain traffic. Asphalt repairs/installation in these areas are recommended under a separate contract in the Spring of 2022. Scope of work is anticipated to exceed the \$50,000 threshold for public bidding. Recommendation to budget the remaining bond proceeds for this project.

- 14.3 **Purchase of Ditch Witch 2550GR Ground Penetrating Radar System** An updated quote was received for the purchase of a Ditch Witch 2550GR Ground Penetrating Radar System = \$26,976.10, whereas, \$26,069.00 was approved in the budget.
- 14.4 **Purchase of Ditch Witch UTG2 Line Locator System** An updated quote was received for the purchase of a Ditch Witch UTG2 Line Locator System = \$4,689.63, whereas, \$4,441.00 was approved in the budget.
- Purchase of 2022 Ford F-250 Crew Cab Pickup Truck A quote for a 2022 Ford F-250 Crew Cab Pickup Truck was received from Landers Ford South = \$42,368.00, whereas, \$36,643.00 was approved in the budget.

Request the use of department vehicle for the class dates and the test dates. Upon completion of this course, the student will have met requirements set forth by NFPA 1521, and become a certified Incident Safety Officer. There is no cost associated with the class, and no per diem is requested. Reimbursement for authorized expenses will be at the rate set forth by the Mississippi State Department of Finance and Administration, Office of Purchasing.
