Mississippi Code Section 67-3-65 gives municipalities the authority to set and enforce such proper rules and regulations and for such other measures relating to the sale of light wine and beer as will promote the public health, morals, and safety, as the municipalities may by ordinance provide.

Pursuant to such regulation, the Mayor and Aldermen of the City of Poplarville, Mississippi, have set forth procedural requirements for the granting of authority for current, active privilege license holders to sell beer and light wine by curbside or drive-up service.

#### **INSTRUCTIONS:**

**APPLICANT:** Submit this application, with original signature, after you have

already been issued a privilege license to sell beer and light wine, and while your license is still current and active, to the City of

Poplarville, 200 Highway 26 East, Poplarville, MS 39470.

CITY CLERK: Upon receipt of an original application, it will be placed on a

pending agenda for consideration by the Mayor and Aldermen.

**CITY BOARD:** At the meeting of the Board of Aldermen, the Board may approve

or deny the application to sell beer and light wine by curbside or drive-up service. The City shall enter a formal Resolution either

approving or denying the application.

CITY CLERK: After the final Resolution has been signed by the Mayor and

Aldermen, the City Clerk will retain the original and forward a

copy to the applicant.
