**CITY PARK/TOWN GREEN USE
RULES & REGULATIONS**

1. Sponsor is responsible for any set-up requirements; operational issues and ensuring that the City Park/Town Green grounds are kept clean and orderly during the event and after the event are returned to the same or better condition in which they were received. **THIS INCLUDES PROVIDING YOUR OWN TRASH BAGS AND REMOVING ALL TRASH CREATED BY YOUR PRIVATE PARTY/EVENT HELD AT CITY PARK.** Failure to completely clean the area will result in additional fees being charged to the sponsor. Time shall be of the essence for this Agreement, and the period of time granted shall not be extended for occupancy or use of the City Park/Town Green or for installation or removal of equipment without permission from the City of Poplarville.
2. The City of Poplarville, the Poplarville Chamber of Commerce, the Farmers Market and the Blueberry Jubilee Council shall have schedule priority over all other Sponsors at the sole discretion of the City of Poplarville and are all exempt from security deposit fees. This Agreement is a license to use and shall not be considered a lease.
3. Sponsor, its agents, employees and representatives, does hereby agree to indemnify, hold harmless and defend The City of Poplarville in connection with all suits, actions, damages, liability, loss of life, bodily or personal injury or property damage arising from or out of any occurrence in, upon, at or from the City Park/Town Green. Sponsor does hereby agree to pay all attorneys' fees arising from or out of any occurrence in, upon, at or from the City Park/Town Green.
4. All events held on the Town Green or in open areas of City Park shall be open and available to the public.
5. Sponsor agrees by execution of this agreement that the City Park/Town Green and adjoining areas are in satisfactory and clean condition. If the City Park/Town Green or adjoining area is damaged by any cause or means whatsoever by Sponsor, its employees, agents, invitees, visitors or event participants, Sponsor shall be responsible for its repair and all costs associated with returning it to their original pre-event condition.
6. Sponsor has permission to use parking in adjoining designated lots for the event. **Sponsor agrees to direct its invitees to use only the designated parking area.**
7. Sponsor shall not allow a larger number of persons than can safely and freely move about in the City Park/Town Green.
8. If at any time the use of the City Park/Town Green by Sponsor or its invitees violates the Rules and Regulations set forth in this document, an applicable ordinance or law of the City of Poplarville, County of Pearl River, State of Mississippi or the United States of America, Sponsor shall either cease and desist from continuing such use or shall surrender the City Park/Town Green forthwith upon demand of the Poplarville Police.
9. Sponsor shall obtain at its own cost commercial general liability coverage with a limit of at least \$1 million, per occurrence, with an aggregate limit of at least \$1 million to cover Sponsor's use of the City Park/Town Green for its scheduled function and name the City of Poplarville as an additional insured or a Certificate Holder on all Certificates of Insurance applicable to the event there under. Sponsor shall, at the time of execution of this Agreement, furnish the City of Poplarville with a copy of said insurance policy or a certification that such insurance has been issued.
